Newtech is committed to manage Focus Materials throughout the recycling chain to final disposition with due diligence to protect workers, the public and the environment.

Compliance:

We will comply with applicable laws and regulations and will implement programs and procedures to assure compliance. Compliance with QEHSMS standards will be a key ingredient in the training, performance reviews, and incentives of all employees.

Risk Reduction, Prevention, Resource Management:

Communication:
